II. LITERATURE REVIEW

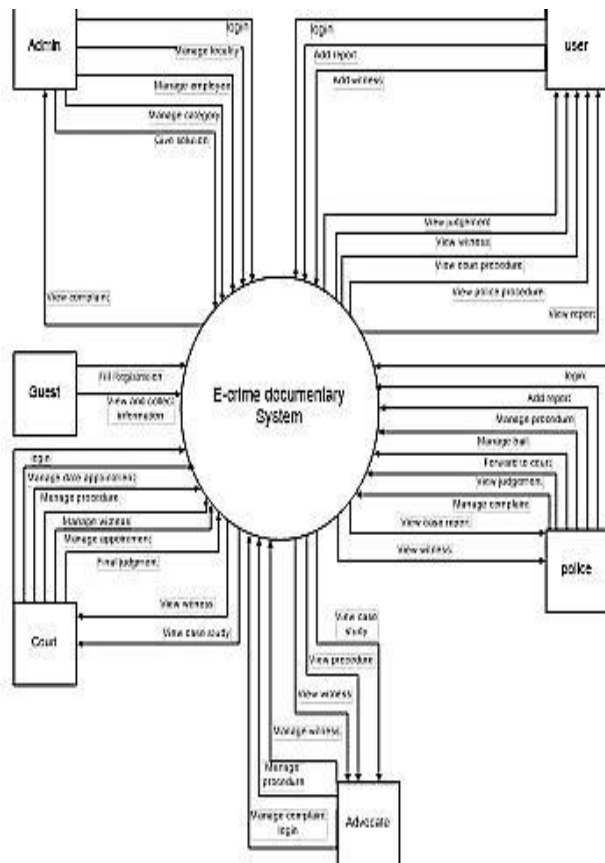
